PROPOSAL FOR A THERMAL-HYDRAULICS BENCHMARK SET

A proposal has been made to the ANS Mathematics and Computation Division, the Thermal-Hydraulics Division and the Nuclear Reactor Safety Division for a Thermal-Hydraulics Benchmark Problem Set. This benchmark set would consist of data from both analytical problems and experimental tests in an organized form, in order of increasing problem complexity, to be used for comparison against thermal-hydraulic computer code predictions. The computer codes used in such comparisons would include lumped parameter system simulation codes, system performance codes, systems analysis codes, detailed best estimate systems codes, and operator training simulator software.

The importance of this activity is based solely on a perceived need by the industry for an organized, complete thermal-hydraulic benchmarking problem set. Only through active participation by committed representatives from interested organizations can this effort be successfully completed.

A committee is being formed by interested persons within the national laboratories, DOE, NRC, the universities and foreign research agencies. A list of the present committee is attached. 



Minutes of the THERMAL HYDRAULICS Division meeting, June 6, 1982.

Members Present: D. Rowe (Rowe & Assoc.), V.E. Schrock UCB); S. Banerjee (UCSB), G.E. Dix (G.E.), B.R. Sehgal (EPRI), P.A. Bergeron (YAEC), M. Corradini (UW), R.T. Lahey Jr. (RPI)

Others present: L. Chiu, E. Gluekler, J. Fillo (part-time), K. Schulze (part-time), E. Fuller (part-time), P. Bailey (part-time)

The Meeting of the Executive Committee was called to order at 5:00 p.m. by D. Rowe.

Chairman's Report

D. Rowe informed the Executive committee about THD Committee reassignments. Chong Chiu will chair the Division Program Committee and V. Esposito will chair the Division Honors and Awards Committee. He also announced that V. Schrock will chair the TH Division in 1982-83 with S. Banerjee as Vice Chair/Chair Elect, G. Dix as Treasurer, and P. Bergeron as Secretary. The new elected members are O. Jones, W. Kirchner, B.R. Sehgal and M. Corradini

2. Secretary's Report:

S. Banerjee asked for approval of the Nov 29/82THD Executive Committee meeting. The minutes were approved.

3. Treasurer's Report

- G. Dix summarized the status of the 1982 THD budget, which is enclosed as Appendix A. He stated that the 1980 carry forward of \$188 had been lost and we should be careful to spend the 1981 carry forward of \$552; otherwise it too would be lost. Several possibilities for spending the carry forward were discussed. The following motions regarding expenditures were unanimously approved:
 - (i) An award of \$150 be made for the best thermalhydraulic paper presented at the 1982 Kiamesha Lake Meeting. N. Todreas to be informed by D. Rowe and given the responsibility for making the necessary arrangements.
 - (ii) An award of \$200 be made for the best paper presented at the 1983 International Topical Meeting at Santa Barbara. M. Merilo to send 5 to 10 outstanding papers to V. Schrock who will strike a special review committee to select the best paper.
 - (iii) An award of \$500 be made for meritorious service at the 1983 International Meeting at Santa Barbara. V. Esposito to make the necessary arrangements for this award.
 - (iv) \$500 be donated to the endowment for the LaMarsh Scholarship.

For items (ii) and (iii) above, the awards are to be made at the D.Q. Kern Award Luncheon of the AIChE, if C. Bonilla (Chair - D.Q. Kern Award Committee) agrees. The announcements are to be kept relatively brief.

4. <u>Program Committee Report</u>

Program Quality

Chong Chiu outlined several ideas for improving the quality of the thermalhydraulics papers presented at ANS meetings. The ideas had been developed in consultation with the Program Committee, D. Rowe and G. Colburn (through D. Rowe). The main points were:

-session topics should not be repeated at intervals less than 12-18 months

-session chairs should be selected early and given considerable responsibility in developing session themes, stimulating papers earlier than the usual ANS announcements and reviewing and commenting on the technical content of papers.

There was some discussion as to whether session chairs should be involved in the Program Committee Review process since there would be some apparent conflict of interest. The point was not resolved. Also the efficacy of this procedure in obtaining high quality papers was questioned, since authors were expected to be reluctant to submit papers to session chairs well before the usual ANS deadlines. This point was also not resolved. The sense of the meeting was that it would be valuable to want for feedback from G. Dix regarding his experience as a session chair for the 1982 ANS Winter Meeting.

V. Schrock suggested that an effective method of stimulating higher quality papers may be to shorten publication time after presentation. This could be done if the ANS journal editors would account reviews of

THD/RSD Overlap

Some concern was expressed by D. Rowe regarding programs overlap with RSD. Rowe, Chiu and Schrock had met with J. Turnage and recognized that there was bound to be some overlap - if only because of the substantial common membership. To minimize potential conflicts, it was suggested that a representative from RSD should sit in on THD program committee meetings and vice versa. P. Bailey agreed to serve as the THD representative in this liaison function. The possibility of co-sponsorship of meetings where there was overlap in interests with other divisions would be considered systematically in future.

S. Banerjee reported briefly on the Int. Topical Meeting in Santa Barbara to be held in January 1983. The technical program was developing well with many more acceptable abstracts being submitted than originally anticipated. The Meeting was attracting considerable international interest e.g. 23 acceptable abstracts has been received from Japan. Protracted negotiations were still going on with the Sheraton Santa Barbara to assure sufficient space for the Meeting. The hotel was reluctant to block a large number of rooms without a cancellation penalty, and the ANS Meetings Manager was reluctant to approve this. Consequently, the Meetings budget was still awaiting approval and the organisational committee was operating with Univ. of Ca. money. Banerjee stated that the problem had to be resolved immediately and he was going to contact the ANS Meetings Manager and strongly recommend immediate budget approval.

Anticipated Transients Meeting

C. Chiu made a brief presentation on a proposal by the Idaho Section to hold a Specialists Meeting on Anticipated Transients in LWRs in September 1983. The Executive Committee felt that the meeting would be timely and well supported. Consequently a motion to endorse the meeting contingent on a similar endorsement by the RSD was unanimously approved. It was also moved and unanimously approved that the Idaho Local Section make the presentation to the National Program Committee.

5. THD Reference Problems

P. Bailey discussed the desirability of putting together a sourcebook of reference thermalhydraulic problems for code development and validation. Rowe stated that there was support for the idea from the Board of Directors. There was some discussion regarding what constituted a proper benchmark problem e.g. what was there beyond some analytical solutions. No decision was reached except that P. Bailey was encouraged

D. Rowe discussed the new membership breakdown format, where the number of multiple memberships in various divisions was shown.

7. Newsletter

- D. Rowe stated that the newsletter was a popular item and he had received very favourable responses from the membership to this effect. Also replies to the questionnaire indicated that the International Topical Meeting at Saratoga had been a real success. Some other points were that:
 - -the majority of respondents interested in serving on THD committees indicated a preference for the Program or Technical Assessment Committees.
 - -with regard to the Newsletter, there was interest in a column on "What's New?"

8. Honors and Awards

The awards approved have been listed in the Treasurer's Report since they involve committment of funds. V. Esposito was made responsible for arranging for a Service Award of \$500 to be presented at the Int. Meeting in Santa Barbara in Jan. 1983.

9. <u>Technical</u> Assessments

The results of the survey were complete and the work was now "dead in the water". However, Rowe felt that there was interest by the ANS President in presenting some important issues to the media (i.e. newsworthy material) at the Winter Annual Meeting in Washington, 1982. He asked those present to suggest ideas regarding possible subjects by July 1, 1982.

The Meeting was adjourned at 7:45 by D. Rowe.

SUPPORT OF STUDENT CONFERENCES - BEST PAPER AWARDS

Each spring the American Nuclear Society sanctions regional student conferences at geographically selected campuses. The main purpose of these conferences is to develop professionalism among participants. To this end technical papers by the students are presented. These papers vary in sophistication ranging from the presentation of advanced graduate thesis research material to the results of undergraduate projects.

The conference organizers solicit papers in all related areas and arrange, as well as possible, to have papers on similar subjects presented in the same session. A panel of professors and/or industry representatives is formed to judge each session. As difficult as it may be, the panel selects a "best paper" for the particular session they are judging.

Traditionally, recognition of each of the best papers is announced at the conclusion of the conference, at which time certificates are given. Often cash awards are also given to the best paper winners. These awards are funded by donations, some of which come from some of the ANS divisions.

If, in the future, contributions are to be made for student conferences, it would be desirable that a letter be sent to ANS Headquarters (sample enclosed) specifying the amount of money your division wishes to designate to student conference awards. These monies will be set aside for the conferences and distributed by the Student Activities Committee of the Education Division.
