## 1. Opening

Bob Martin called the THD Executive Committee Meeting to order at 5:15 p.m.

## 2. Approval of meeting Agenda

The meeting agenda was introduced (Attachment B) and was approved.

## 3. Minutes from June 2005 Annual Meeting (San Diego)

The meeting minutes from the November 2005 meeting in San Diego were approved as amended to correct adding Xiaodong Sun to the session of "General Thermal Hydraulics" and adding a session of "Thermal Hydraulics Professional Competition" chaired by Shripad Revenkar and Larry Hochreiter

#### 4. Action Items from June 2005 Annual meeting

## a. Bylaws Changes:

The THD bylaws were distributed among THD members and the updated one was distributed in October. A few votes were cast upon the requested revision, but remaining votes must be obtained.. In the updated bylaws, we included several changes regarding the election of officers and other issues. THD bylaws will need to be changed to the Standard Bylaws. The THD agreed that we would like to include our proposed changes. However, the Bylaw and Rules Committee is not happy with the changes we made.

*Action*: Bob will send us the updated version of bylaws later and, following EC approval, will provide the bylaws revision to the Bylaws and Rules Committee.

## b. Membership list:

The email list is not updated yet with approximately 40 emails returning.

Action: Kurshad and Bob will work together to find the most up-to-date email list.

#### c. NED Contact

Yassin Hassan will contact NED to facilitate publication of selected papers from NURETH-11. Yassin needs good reviewers. Yassin has begun the process of organizing the NED special edition.

#### 5. Treasurer's report

The THD budget proposal for 2006: Total \$5,500 (\$2500 for awards and plaque, \$2000 for student support, \$500 student travel, and \$500 for scholarship/NEED program): Two motions were on the table; one for \$2,500 for student support and the other for \$2,000 for student support. EC voted for the latter motion with 7 to 1 in favor.

#### 6. Program Committee Report

#### a. NURETH-11 report

There were nearly 500 meeting registrants representing approximately 31 countries. Presentation of nearly 400 papers plus additional presentations appearing in two special topics sessions provided the technical portion of the meeting.

Dr. Graham Wallis, professor emeritus at Dartmouth University and Chairman of the USNRC's Advisory Committee on Reactor Safeguards, provided a plenary presentation; Dr. Richard Lahey, professor emeritus at Rensselaer Polytechnic Institute, also provided a plenary presentation; and Dr. Novak Zuber, retired USNRC, was presented a Medal of Honor from the Société Française de l'Energie Nucléaire for his lifetime achievements.

THD is not entitled to revenue incomes from NURETH-11 due to class-4 category.; however, the THD will try to establish a restricted funds account for which the NURETH organization can donate some proceeds.

Action: Bob will look into this possibility.

#### b. NURETH-12 report

NURETH-12 dates are from September 30 to October 4, 2007. Scheduled events include:: Welcome reception on Sunday, dinner cruise on Monday night, and award ceremony on Tuesday. The award ceremony is included in the registration fee. The early registration will be \$500, while the late registration fee is \$750.

## c. NURETH-13 report

Japan wants to hold Nureth-13. India might also be interested. It is planned to invite proposals from US and foreign countries; Selection committee members who volunteered are Yassin Hassan, Bob Martin, Bill Cheung, and Karen Vierow.

#### d. Others

#### RPI:

Joe Fricano and Paul Kollath-Romano from RPI presented the 2006 American Nuclear Society Student Conference which will be held in RPI from March 30 to April 1, 2006. The detailed information can be found in <a href="http://ans.union.rpi.edu/Conference/">http://ans.union.rpi.edu/Conference/</a> This event is hosted by Rensselaer Polytechnic Institute.

Dave Pointer, a representative for International Youth Nuclear Congress, presented the 2006 IYNC which will be held in Stockholm, Sweden. In the past, ANS contributed \$8000. They have already received 200 abstracts, and the expected registration fee is \$600.

## 7. Honors & Awards Committee Report

#### a. TAA:

Cetin reported that five candidate packages were submitted. Two TAA winners were selected:: Bill Sha and Vijay Dhir.

## b. Best paper

A subcommittee (Cetin Unal, Karen Vierow, and Chang Oh) selected the best paper out of sixteen papers submitted by NUTHOS-6 representative. The best paper award was given to E. Baglietto and H. Ninokata for their paper entitled "CFD Modeling of Secondary Flows in Fuel Rod Bundles." Because there was an issue about the voting process applied this year, it

was agreed that the THD needs to formalize the procedure to select the awards.
